ARTICLES OF INCORPORATION

The undersigned, all of lawful age and citizens of the United States of America, hereby associate ourselves together for the purposes of becoming a not-for-profit corporation under the laws of the State of Florida.

I.

The name of the corporation shall be:

CALVARY COMMUNITY CHURCH OF SUMMERFIELD, INC.

II.

This church, believing the Bible to be the inspired Word of God, and the only divinely authorized rule of faith and practice, and acknowledging its adherence to all teachings of Jesus Christ, declare and incorporate for the following purposes:

1. Evangelism/Missions: to proclaim the Gospel of Jesus Christ to the lost and to promote the cause of world evangelism and missions.
2. Teaching/Discipleship: to preach and teach the Word of God for the edification, instruction and disciple of believers, and to promote Christian education.
3. Benevolence: to minister to the suffering and needy.
4. Worship/Fellowship: to maintain regular services for both devotional and public worship, and to promote the spiritual welfare of all church families through Christian education and personal

spiritual development.

5. Real and Personal Property: To hold real and personal properties in common for religious, educational, social, fraternal or charitable purposes.

III.

This Corporation is organized exclusively for charitable, religious and educational purposes consistent with §501(c)(3) of the Internal Revenue Code as it now exists or as it may be amended from time to time.

IV.

Every person who is admitted to voting membership in the Calvary Community Church of Summerfield according to its By-Laws and constitution shall be a member of this Corporation.

V.

This Corporation shall have perpetual existence.

VI.

The affairs of the corporation shall be managed by the officers of the corporation as set forth in Article VII below. All officers shall be elected annually and the election shall occur at an annual business meeting of the Board of Directors of the Corporation and as provided in the By-Laws of the Corporation.

VII.

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal revenue Code as amended from time to time.

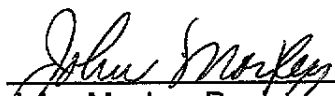
