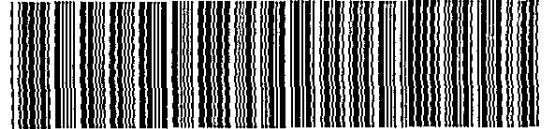

Current Article XV

The Church Board shall provide a Corporate Seal that shall be in the form of a circle and shall have inscribed thereon the name of this Church. The Seal will consist of a wreath (the Victor's Wreath) with a two-edged Sword in its midst. Within the Wreath and above the Sword shall be the Scripture reference Hebrews 4:12. Arching above and outside the Wreath shall be the name Hope Bible Church.

Change

The Church Board shall provide a Corporate Seal that shall be in the form of a circle and shall have inscribed thereon the name of this Church. The Seal will consist of a wreath (representing the Victor's Wreath, received for a life of faithful service to God – Rev 2:10C) with a two-edged Sword in its midst and a ribbon extending horizontally at the bottom of the Wreath (representing the rewards a believer receives in addition to the wreath – 1Cor 3:8). Below the Wreath and Sword shall be the scripture reference Hebrews 4:12 in the form of an inverse arch. Arching above the tip of the Sword shall be the name Hope Bible Church.


