ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: NewACTS Communities of Florida, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The Corporation is incorporated under the Chapter 617 of the Florida Statutes for the following purpose or purposes: Being persuaded upon careful perusal of the Holy Scriptures that one of the responsibilities of the Gospel message is to provide for the social needs of humanity in this life on earth, particularly for the elderly -- Acts 6:1-3; James 1:27; I Timothy 5; Luke 10:25-37; Exodus 20:12 -- therefore, the objects of this Corporation are to fulfill these needs by providing for the total care of the elderly, including housing, sustenance, medical and other physical needs as guided by the Scriptures. The Corporation is organized exclusively for charitable, religious, and educational purposes to meet the social, spiritual, personal, and healthcare needs of senior citizens in a Christian environment and to provide continuing care for senior citizens in retirement communities guided by the precepts set forth above. These purposes include making distributions to organizations with compatible purposes that qualify as exempt under §501(c)(3) of the Internal Revenue Code of 1986, or a successor statute of similar import (hereinafter the "Code"). The Corporation does not contemplate pecuniary gain or profit incidental or otherwise.

No gift or grant will be accepted if it contains major conditions which would restrict or violate any of the Corporation's charitable, religious, or educational purposes, or if it would require serving a private as opposed to public interest.

The Corporation shall seek such sources of support, including program service revenue and the solicitation of grants from private sources and direct or indirect contributions from the general public, as may be necessary to enable it to qualify as a publicly supported organization. Distribute its income for each tax year at such time and in such manner so that it will not become subject to the tax on undistributed income imposed by §4942 of the Code.

Not engage in any act of self-dealing as defined in §4941(d) of the Code.

Not retain any excess business holdings as defined in §4943(c) of the Code.

Not make any taxable investments as defined in §4944 of the Code.

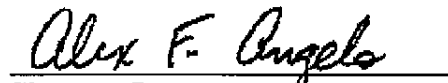
