## ONE:

The Name and address of this principal corporation is Monticello Christian Center, Inc, is Post Office Box 6617, Tallahassee, Florida 32314, in Leon county. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.

## TWO:

This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law, for spiritual, charitable and educational purposes. To bring encouragement and aid the poor, disadvantaged, depressed, oppressed individuals and families to help bring joy and self-sufficiency. The programs shall consist of but not limited to: Community Worship, Seminars, Outreach Advocacy Programs for the Homeless, and Disadvantaged, Health Care, food bank, Housing, Employment, Literacy, Counseling, Teenage Pregnancy, Job Training, Placement and Acquisition, Substance Abuse Awareness and Prevention, tutoring, television outreach and other programs to aid those in need.

## THREE:

The duration of this corporation shall be perpetual, and shall have no stock.
