ARTICLES OF INCORPORATION

OF

EMMAUS BAPTIST CHURCH OF TALLAHASSEE, INC.

The undersigned Incorporators hereby file these Articles of Incorporation in compliance with Chapter 617, F.S., (Not for Profit).

ARTICLE I.

Name

The name of the corporation shall be **EMMAUS BAPTIST CHURCH OF TALLAHASSEE, INC.**

ARTICLE II.

Principal Office

The principal office of this corporation is 1897 Raymond Tucker Road, Tallahassee, Florida 32311.

ARTICLE III.

Purpose

This Corporation is organized exclusively for religious purposes, including charitable functions common to a pastoral church ministry.

ARTICLE IV.

Officers

The Corporation shall have a Board of Directors, with no less than three (3) members on said Board. The Board shall designate a Chairman by majority vote.

Any Board Member may resign by giving written notice to the Chairman of the Board. If the resignation is to take effect at some time in the future, a successor may be selected prior to the effective date of resignation.

Any Board Member can be removed from office at any regular or special meeting of the Board if that Member is found to be physically or mentally incapacitated, or spiritually unqualified (as outlined in the By Laws), after a thorough investigation by the Board.

A vacancy shall be deemed to exist in the case of death, resignation or removal of any Board Member. In the event of a vacancy for any reason, recommendations to fill the vacant office shall be requested from all congregation members. The Chairman of the Board shall appoint a Nominating Committee, which shall consist of not less than five (5) Ministry Leaders. This Committee shall review all nominations and determine each member's qualifications. The proposed slate of nominees prepared by the Nominating Committee shall be submitted to the Board of Directors along with any relevant comments. The Board will then make the final decision by majority vote.

ARTICLE V.
Initial Board of Directors

The initial Board of Directors shall consist of three (3) persons. The names and street addresses of the members of the initial Board of Directors of this Corporation who shall hold office are as follows:
