# `ARTICLES OF INCORPORATION OF OMMUNITY TECHNOLOGICAL INSTITUTE OF

COMMUNITY TECHNOLOGICAL INSTITUTE OF MIAMI, ING (A Not-For-Profit Corporation)

#### Article I NAME

The name of this organization shall be the **Community Technological Institute of Miami, Inc.** 

## Article II PRINCIPAL OFFICE

The street and mailing address of the Corporation's principal office is 12955 Biscayne Blvd., #326, North Miami, Florida 33181, and the name of the Corporation's initial register agent at that address is Evelyn Jordan.

#### Article III PURPOSE

This corporation is a not-for-profit corporation, organized for the purpose of creating an educational institution which will provide disadvantaged and minority students with a tailored psycho-educational program to enhance essential life and work skills and for the purpose of engaging in any in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida and Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended.
