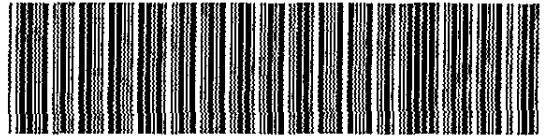

ARTICLES OF AMENDMENT

These Articles of Amendment of **JOURNEY OF FAITH COMMUNITY CHURCH, INC.** being proposed and recommended by the Board of Directors and being approved by unanimous vote of the Board of Directors of **JOURNEY OF FAITH COMMUNITY CHURCH, INC.**, the Articles of Incorporation are amended as follows:

1. **ARTICLE V**, shall read as follows:

The officers shall be a President, Vice President, Secretary and a Treasurer. The Officers shall be chosen by majority vote of the directors. All officers shall hold office at the pleasure of the Board of Directors. The Board of Directors may also appoint, at its pleasure, a pastor and such assistant pastors as may be deemed necessary in accordance with the By-Laws of the corporation.

The officers shall be Daniel Lyons as President, Charles E. Garrett as Vice President, Melody A. Lyons as Secretary and Lisa I. Garrett as Treasurer.

2. **ARTICLE VII**, shall read as follows:

3. **ARTICLE VIII**, shall read as follows:

- a) The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code.
- b) No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.
