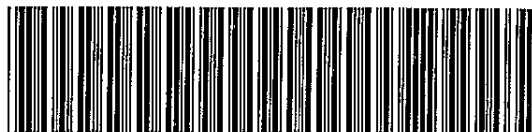

## **Articles of Amendment**

### Article I

#### Name

This organization shall be known as Cross-Walk Center for Youth and Community Development, Inc.

### Article II

#### Principle Office

501 South Lawrence Boulevard, Keystone Heights, Florida, 32656

### Article III

#### Purpose

The purpose of this Organization shall be to initiate programs in the community designed to strengthen family ties and assist youth in personal achievement and in community development.

Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations under Section 501(c)(3) purposes of the Internal Revenue Code (or the corresponding section of future Federal tax code).

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

Upon dissolution of this corporation assets shall be distribute for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distribute to the Federal government, or to a State or local government, for a public purpose.

Article IV  
Manner of Election

The Executive Director of Cross-Walk: A Learning Community, as Chairman of the Board of Cross-walk Center for Youth and Community Development shall choose two additional candidates to serve on the Board of Directors for the first fiscal year.

At the first annual meeting, the Board of Directors shall elect two new members at the annual meeting.

After the second fiscal year, one member of the original board may step down; the four remaining members shall elect one new member to serve a two-year term.

Board members shall be required to serve a two-year term. At that time the member may step down or serve an additional year without being elected.

After three years on the Board of Directors, members must be re-nominated and re-elected to the Board of Directors. The Chairman of the Board is exempt from this condition.
