**ARTICLE VIII.**

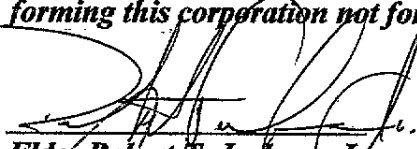

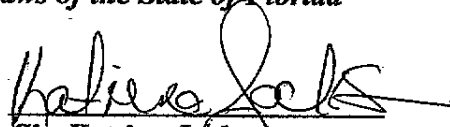
