

ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

THE ANDREW R. FERRELL FOUNDATION, INC.

The undersigned, being the President and Vice President of the Andrew R.

Foundation, Inc. hereby certify that the following Amendment to the Articles of Incorporation was duly adopted at a regularly called meeting of the Board of Directors of The Andrew R. Ferrell Foundation, Inc. pursuant to Article XIII of the Articles of Incorporation, this 24th day of February, 2003. There are no members entitled to vote on this amendment.

AMENDMENT

FIRST: The Articles of Incorporation of THE ANDREW R. FERRELL FOUNDATION, INC., are amended as follows:

ARTICLE III: PURPOSE

A. This corporation is being formed for the purpose of raising funds in support of programs and organizations which benefit children who are experiencing life threatening illnesses, within the meaning of Section 501©)(3) of the Internal Revenue Code. That is, it shall be exclusively to conduct fund raising programs and events, and to use the funds generated by such efforts to support and establish programs and organizations whose services enhance the lives of children affected by life threatening illnesses. All activities of the corporation shall be conducted within the laws of Florida and of the United States.

- B. Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- C. This corporation is irrevocably dedicated to and operated exclusively for nonprofit purposes; and no part of the income or assets of the corporation shall be distributed to, nor inure to the benefit of its members, trustees, officers or other private persons. except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document the organization shall not carry on any activities not permitted to be carried on by (a) an organization exempt from federal income tax under section 501@)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) an organization, contributions to which are deductible under section 170©)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- D. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such

assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such reorganization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

2) Article X is amended to reflect that the address for the registered agent is now 46 N.. Washington Blvd, Suite 21, Sarasota, Florida 34236.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
