Pursuant to the provisions of section W1.1006, Florida Statutes, this Florida non-profit corporation adopts the following articles of amendment to its articles of incorporation:

Amendments adopted: Article Three being amended as follows:

The purposes for which the corporation is organized are exclusively religious ,charitable, scientific, literary, and educational within the meaning of section 501°C(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article Eight being added as follows:

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 O(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article Nine being added as follows:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not to be disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

The date of each amendment's adoption is November 29, 2002.

The amendments were adopted by the board of directors. There are no members or members entitled to vote on this amendment.
