**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to Section 617.1006 of the Florida Statutes, the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation:


FIRST: Article I of the Articles of Incorporation of 211 TAMPA BAY CARES, INC. (the "Corporation") is hereby amended to read as follows:
