Article III: Purpose

1) Dominican Cultural Week, Inc.(the "Corporation") is organized to promote cultural and educational activities, such as conference, seminar, exposition, festival, parade, patriotic related commemoration, sporting event.. To be a voice of Dominican American concerns in community affairs. To facilitate communication between The Dominican Republic and the Dominican American community in Tampa Bay.
