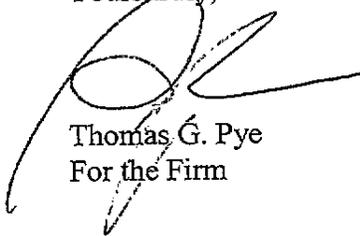

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a corporation under the Florida Not for Profit Corporation Act of the Florida Statutes, and hereby adopts the following Articles of Incorporation:

ARTICLE 1- NAME

The name of the Corporation is Fundacion Nuestro Abrazo, Inc., hereafter referred to as "Corporation".

ARTICLE 2 - PURPOSE OF BUSINESS

The purpose of this Corporation is to raise, hold, invest, and contribute money and new or used consumer goods for the benefit of unfortunate people in Argentina. In addition, the corporation shall conduct and exist for other general charitable purposes as allowable under IRS section 501(c) ( 3 ); as well as all other legal activities allowable under law for a not for profit corporation.

The purposes for which the corporation is organized are exclusively, religious, charitable, scientific, literary, and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from

Federal income tax under section 501(c) (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of this corporation is 2941 NE 1<sup>st</sup> Avenue, Fort Lauderdale, Florida 33334 and the mailing address is the same.

#### ARTICLE 4 - INCORPORATOR

#### ARTICLE 5 - OFFICERS

The officers of this Corporation shall be:

President: Ruben Oscar Valido

Vice president/Secretary: Teresa Arenas

whose address shall be the same as the principal address of the Corporation.

#### ARTICLE 6 - DIRECTORS AND MANNER OF ELECTION

The Directors of the Corporation shall be: Ruben Oscar Valido, Fernanda Maria Arenas and Teresa Arenas and whose address shall be the same as the principal office of the Corporation

Directors shall be elected by appointment by the members of the corporation on an annual basis.

#### ARTICLE 7 - POWERS OF CORPORATION

The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.

#### ARTICLE 8 - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Code, or to the federal, State or Local government for exclusive public purpose.

#### ARTICLE 9 - REGISTERED OWNER

The Corporation, to the extent permitted by law, shall be entitled to treat the person in whose name any share or right is registered on their books of the Corporation as the owner thereto, for all purposes, and except as may be agreed in writing by the Corporation, the Corporation shall not be bound to recognize any equitable or other claim to, or interest in, such share or right on the part of any other person, whether or not the Corporation shall have notice thereof.

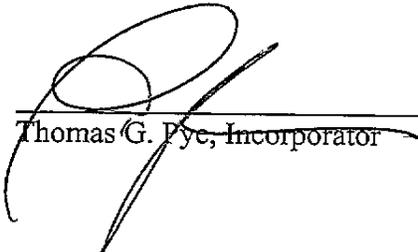

the Secretary of State, State of Florida.

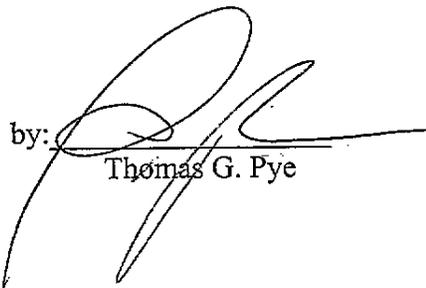
