**ARTICLES OF INCORPORATION OF
WORKER'S UNION FOR CUBAN CHILDREN, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: Worker's Union for Cuban Children, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - PURPOSE

The specific purpose for which the corporation is organized is to assist the children in Cuba, particularly the medically needy children. The corporation is a non-political organization and its mission is strictly humanitarian.

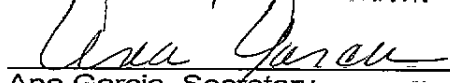

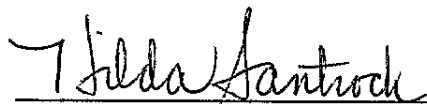
