Article III "Powers and Duties" of the Articles of Incorporation of Chau Subdivision Home Owners Association, Inc. shall be amended to add "Section 3 - Operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas." and "Section 4 - The articles of incorporation shall provide that if the association is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that if no accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the association."
