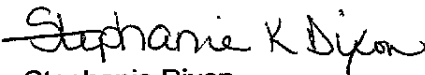

ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be GENTLE SPIRIT DOULAS, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized are:
