ARTICLES OF INCORPORATION OF THE ALLIANCE OF EDUCATIONAL LEADERS, INC. A FLORIDA NOT FOR PROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a corporation not for profit, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I. NAME AND ADDRESS

The name of this corporation is THE ALLIANCE OF EDUCATIONAL LEADERS, INC. (the "Alliance"). The principal place of business and mailing address of the corporation is 10501 FGCU Boulevard South, Fort Myers, Florida 33965-6565.

ARTICLE II. PURPOSES

The general nature of the objects and purposes of this corporation are educational, specifically:

- 1. To ensure the educational process is a seamless web from the pre-kindergarten through university graduate level.
- 2. To produce a national model of cooperation between regional educational organizations which focuses on enhancing the quality of education, increasing opportunity for students, promoting higher graduation rates, and increasing the level of job placements for graduates within Southwest Florida.
- 3. To emphasize school readiness for students at all levels of the educational system.
- 4. To emphasize teacher education programs which produce graduates who are qualified to provide excellent teaching and administration.

- 5. To network with business and governmental entities to develop educational programs which produce a workforce geared to meet and increase the region's economic prosperity.
- 6. To solicit support of governmental leaders, business, industry and community organizations to advance the mission of the Alliance.
- 7. To do any and all things necessary and appropriate in connection with the foregoing purposes and incidental thereto.
- 8. The corporation's purposes are hereby limited in such a manner as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code") or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Code, including private foundations and private operating foundations.

ARTICLE III. QUALIFICATIONS OF MEMBERS

Membership eligibility in the Alliance shall consist of the superintendents of the public school systems of Charlotte, Collier, Glades, Hendry and Lee Counties, and the chief executive officer of any public or independent college or university that meets all of the following criteria: (1) regionally accredited; (2) licensed in the State of Florida, and (3) operating in Southwest Florida. Additional members may be approved by a majority vote of the existing Alliance members.

Provisional membership eligibility in the Alliance shall consist of the chief executive officer of any public or independent college or university that meets <u>all</u> of the following criteria:

(1) is recognized by a regional accrediting agency as a candidate for regional accreditation, and is pursuing such accreditation; (2) licensed in the State of Florida, and (3) operating in Southwest

Florida. Provisional membership provides for the chief executive officer to hold a non-voting seat on the Alliance Board of Directors. Formal notice of regional accreditation shall automatically convert a Provisional member to regular Membership that has voting and all other rights of membership.

ARTICLE IV. TERM OF EXISTENCE

This corporation shall commence upon the filing of these Articles and shall exist perpetually thereafter.

ARTICLE VI. BOARD OF DIRECTORS

Section 1. The business affairs of this corporation shall be managed by the Board of Directors. This corporation shall have ten (10) Directors initially. The number of Directors may be increased or decreased from time to time, by the Bylaws but shall never be less than three (3).

<u>Section 2.</u> The Board of Directors shall be members of the corporation.

<u>Section 3.</u> Members of the Board of Directors shall be elected and hold office in accordance with the Bylaws.

Section 1. No part of the net earnings or assets of the corporation shall inure to the benefit of any individual, member, director, or officer.

<u>Section 2.</u> The corporation shall not carry on propaganda, or otherwise act to influence legislation.

Section 3. No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed exclusively to organizations with educational purposes which have qualified for exemption under Code Section 501(c)(3), and none of the assets will be distributed to any member, officer, director or trustee of this corporation.

Section 4. These Articles of Incorporation may be amended at any meeting of the Board of Directors by majority vote of the directors then in office.
