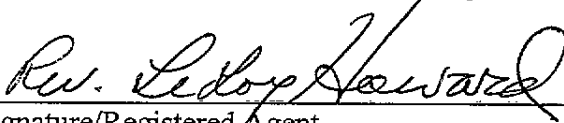
Article VIII - Limitation of Corporate Powers

The Corporate Powers of this Corporation are as provided in §617.0302, Florida Statutes, except that notwithstanding such powers, the Corporation shall not carry on any activities not permitted to be carried on by any organization exempt from Federal Income Tax under §501(C)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law. No part of the earnings of the Corporation shall inure to, or be payable to, or for the benefit of any private shareholder or individual, and no substantial part of the activities of this Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. No part of the activities for the Corporation shall be the participation of intervention (including the publishing or distributing of statements) in any potential campaign on behalf of any candidate for public office. This Corporation shall not discriminate on the basis of race, color, religion, sex, national origin, age or handicap.

Article IX - Permanent Dedication of Assets

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes with the meaning of section 501c(3), of the Internal Revenue Code of 1986, or corresponding section of any future Federal Tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction for the county in which the principal office of this organization is then located, exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
