**ARTICLES OF INCORPORATION
OF
Rebecca At The Well Foundation, Incorporated**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **Rebecca At The Well Foundation, Incorporated**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: a non-profit Judeo-Christian organization devoted to inspiring true believers to prepare for the return of the Messiah, by informing people of faith through literature the way to walk in the beauty of holiness, and motivate members of the body to be clothed with righteous acts and deeds as the Bride of Christ. To provide workshops and seminars to all believers on how to make themselves ready as a pure and holy bride. To bridge a gap of ignorance between religions, by teaching about the common threads of many faiths, binding us together as one body. To be an avenue of goodwill by publishing and providing great literary works that will unite all believers to celebrate His return. To inspire men and women to be clothed in splendor by providing community service through acts of kindness. To educate young members of the bridal party, to study and work in an environment of compassion, acceptance and respect, by offering practical workshops on the whole person: body, soul, and spirit, with subjects such as childcare, health, fitness, and writing.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
