## ARTICLES OF INCORPORATION

OF

**Immokalee Life & Family Center, Inc.,**  
a Florida not-for-profit corporation

EFFECTIVE DATE

**THE UNDERSIGNED**, acting as sole incorporator of a corporation to be formed under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation:

**FIRST:** The name of the corporation (the "Corporation") is:

**Immokalee Life & Family Center, Inc.,**  
a Florida not-for-profit corporation

**SECOND:** The principal office or mailing address of the Corporation is: **Post Office Box 1590, Immokalee, Florida 34143.**

**THIRD:** The period of duration of the Corporation is perpetual, unless dissolved according to law.

**FOURTH:** The street address of the initial registered office of the Corporation is:

550 North 19<sup>th</sup> Street, Immokalee, FL 34142

and the name of the Corporation's initial registered agent at such address is:

**JEANNETTE H. BELLMAN**

**FIFTH:** The number of directors constituting the initial Board of Directors of the Corporation is three (3), and the names and addresses of the persons who are to serve as directors of the Corporation until the first annual meeting of the members of the Corporation, or until one or more successors have been elected and qualify, are as follows:

**SEVENTH:** The purpose for which the Corporation is organized is for any lawful purpose or purposes not for pecuniary profit and not specifically prohibited to corporations under Chapter 617, Florida Statutes, specifically including religious and charitable purposes.

**EIGHTH:** The qualifications for members of the Corporation and the classes of memberships shall be as established in the Corporation's Constitution and By-Laws, as from time-to-time in existence.

**NINTH:** The Corporation is organized under a non-stock basis.

**TENTH:** No part of the Corporation's net earnings shall inure to the benefit of or be distributable to its Members, Directors, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article SEVENTH of these Articles of Incorporation.

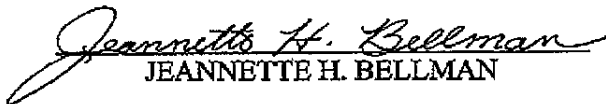
**ELEVENTH:** This Corporation will not carry on any activity not permitted to be carried on by (a) a corporation exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law

**TWELFTH:** Upon the dissolution of the Corporation, the Corporation's assets shall be distributed only to another corporation that are subject to restraints substantially similar to those imposed on the Corporation by Articles TENTH, ELEVENTH, and TWELFTH of these Articles of Incorporation.

**THIRTEENTH:** Corporate existence of the Corporation shall commence on July 15, 2002.

**FOURTEENTH:** The Corporation is organized and shall be operated exclusively for religious and charitable purposes.

IN WITNESS WHEREOF, the undersigned, being the sole incorporator hereinbefore named, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, has executed these Articles of Incorporation, this 15 day of July, 2002.
