

ARTICLES OF INCORPORATION

of

THE CAVALRY OF GOD FOR CHRIST JESUS MINISTRY, INC.



A Not-Pay-Profit Corporation

Pursuant to the provisions of the Florida Not For Profit Corporation Act, the undersigned incorporator hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: THE CAVALRY OF GOD FOR CHRIST JESUS MINISTRY, INC.

ARTICLE II

The principal place of business and mailing address of the corporation shall be: 6738 Pearson Lane, Wesley Chapel, FL 33544

ARTICLE III

The purpose for which the corporation is organized is to feed, clothe and shelter the homeless and unfortunates. The corporation will also promote christian values through education, charity, ministry and any and all other appropriate means.

This corporation is organized exclusively for one or more purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE_IV

The manner in which the directors are elected or appointed shall be stated in the bylaws.

ARTICLE V

ARTICLE VII

Additional provisions:

Upon the dissolution of this corporation, its assets remaining after payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors officers or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductable under Section 170(c)(2) of the Internal Revenue Code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familar with and accept the appointment as registered agent and agree to act in this capacity.
