ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

The name of the corporation shall be Canine Rescue and Rehabilitation, Inc.

ARTICLE II: PRINCIPAL OFFICE
