ARTICLES OF INCORPORATION

In compliance with chapter 617, F.S., (not for profit)

ARTICLE I - NAME

The name of the corporation shall be:

International Philippine Martial Arts Grandmaster's Union and Hall of Fame, Inc..

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be :

5949 Caroline Drive, Wesley Chapel, Florida, 33544.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is:

PRIMARY PURPOSE: To propagate the Philippine martial arts culture, induct grandmasters and prospective grandmasters of the Philippine martial art, as well as foreign martial culture to the union hall of fame to promote understanding and respect between martial artists, hold annual festival to generate revenues to finance Filipino martial culture activities; conduct, promote or sponsor seminars by member or non-member grandmasters to propagate the art; publish books, magazines, or produce videos as a means of information or instructions to practitioners of the Filipino martial arts, to open school or schools necessary to achieve objectives in propagating the arts; buy or make training weapons, armor, uniforms, punching bags, gloves or any equipment necessary to implement teaching to propagate the Filipino martial art heritage and do other activities domestic or otherwise which are directly necessary in achieving the primary purpose of the organization, and make contribution to charity when finances permit.

SECONDARY PURPOSE: To buy, lease, rent, exchange, or restore, sell any tools and equipments manual or power operated that are necessary to implement the preceding primary purpose; to acquire appliances necessary for the operation of the corporation, acquire or buy materials needed to produce any product and equipment necessary for the pursuant of the above-mentioned primary purpose.

Incidental to the above general purpose, to acquire, own, improve, build and maintain real estate and interest therein, together with such buildings, fixtures and equipments as maybe necessary or desirable; to apply for grants or barrow money and incur liability by mortgage or lien upon its real estate and other property; and to do all and anything lawful and proper which may be necessary or appropriate for the accomplishment of the purposes or the attainment of the objectives herein-above stated or furtherance thereof.

ARTICLE IV - MANNER OF ELECTION

The corporation shall be managed by the board of directors and shall be elected or appointed by the incorporators of the corporation; and shall hold office until the next annual meeting of incorporators until their successors shall have been elected and qualified.
