# **Articles Of Incorporation**

In Compliance with Chapter 617, F.S., (Not for Profit)

### Article I Name

The name of the corporation shall be: Skywatcher Music Ministries, Inc.

# Article II Principal Office

The principal place of business and mailing address of this corporation shall be: 4642 Twelve Oaks Court
Jacksonville, Florida 32210

# Article III Purpose

The purpose for which the corporation is organized is:

As a Christian-based charitable religious organization dedicated to increase the public knowledge of the love of our Savior, Jesus Christ and the benefits of a Christian lifestyle. Conduct of the corporation shall be within the limits of section 501(c)(3) of the Internal Revenue Code. Skywatcher Music Ministries, Inc. shall support and assist other section 501(c)(3) Christian based charitable, relief and missionary organizations in their efforts to bring the love of Jesus Christ to all people who wish to receive his love, in the community and around the world. Skywatcher Music Ministries, Inc. shall utilize the live presentation, recording, promotion and distribution of gospel music as it's primary method of communicating the love of Jesus Christ and raising funds. Skywatcher Music Ministries, Inc. shall provide spiritual, financial and physical support for other Christian based charitable and relief organizations. Skywatcher Music Ministries, Inc. shall further the common welfare and well-being of the Christian community only in a charitable manner that complies with section 501(c)(3) of the Internal Revenue Code of the United States of America.

#### Article IV Manner of Election

Directors/Officers of Skywatcher Music Ministries, Inc. shall be elected by simple majority vote of the Board of Directors and may serve a term in office whose length shall be set forth in the bylaws of the corporation unless removed from office for cause by simple majority vote of the Board of Directors, voluntary retirement or death. There shall be a minimum of three directors on the Board of Directors. Additional directors shall be added to the board only in accordance with the bylaws of the corporation.

## Article VIII Dedication of Assets

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to it's members, Directors, Officers, or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX Asset Distribution in the event of Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located.

# Article X Indemnification of officers

Skywatcher Music Ministries, Inc. shall indemnify and hold harmless the Directors and Officers of the corporation for any lawful actions taken on behalf of the corporation, if they have acted within his/her official capacity and according to their given responsibilities, as set forth in the Articles of Incorporation and the Bylaws of Skywatcher Music Ministries, Inc., as long as they have acted in good faith and as a reasonable, competent, law abiding person would act in a similar situation.
