

- ONE:** The name and address of this principal corporation is Domestic Deliverance In Progress, Inc. 4839 Pine Aire Lane, West Palm Beach, Florida 33417 in Palm Beach County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, Educational and Charitable purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Mentoring, Job Training, Job Placement, Food Pantry, HIV/AIDS, Counseling, Chemical Dependency, Spousal Abuse, Seminars, Workshops, Information Referrals & Assistance, and other programs to aid those who are in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.

- (B) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501C (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 C (2) of the Internal Revenue Code.


**SIX:** The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:
