ARTICLES OF INCORPORATION OF
ELITE PHYSIQUES YOUTH PROGRAM, INC.

I, the undersigned, acting as incorporator of a corporation pursuant to Chapter 617, F.S., (non Profit), adopts the following Articles of Incorporation to become a Florida Corporation not for profit:

ARTICLE I

Name

The name of the corporation shall be: ELITE PHYSIQUES YOUTH PROGRAM, INC.

ARTICLE II


