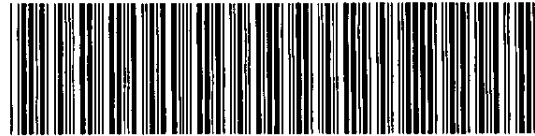

**ARTICLE I**

The amended new name of the Corporation is:

**NORTHEAST FLORIDA URBAN & RURAL COMMUNITY DEVELOPMENT, INC.**

**ARTICLE II**

a. The general purpose of this Corporation is to have and exercise all rights and powers conferred on Nonprofit Corporations under the codes and laws of the State of Florida, provided that this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its primary purposes. It shall engage in any lawful acts or activities for which a Nonprofit Corporation may be organized and permitted to operate under the General Corporation Codes and Laws of the State of Florida and the Department of the Treasury, Internal Revenue Service Codes § 501(c)(3) et seq.

b. In addition to its general purposes this Corporation is organized for public and charitable purposes to provide support and assistance with counseling, educating, training, tutoring, mentoring, fostering, servicing or otherwise in accordance with this Corporation's Bylaws and guidelines and the applicable codes and laws of the State of Florida and § 501(c)(3) et seq. of the Department of the Treasury, Internal Revenue Service Codes.

**ARTICLE III**

Through contributions or otherwise this Corporation shall accumulate resources and obtain the necessities needed to meet this Corporation's needs, the needs of the community abroad, the needs of Nonprofit Public Benefit, Charitable and Religious Corporations and to maintain a fund and administer or distribute funds within this Corporation's Bylaws and guidelines and § 501(c)(3) et seq. of the Department of the Treasury, Internal Revenue Service Codes and the applicable General Corporation Codes and the Laws of the State of Florida.

**ARTICLE IV**

The territory in which the operations of the Corporation are principally to be conducted is the State of Florida, however, the Corporation shall not be limited or restricted to such territory, but shall conduct its business affairs in the United States of America.

**ARTICLE V**

- a. No part of the earnings of this Corporation shall inure to the benefit of or be distributed to any private person for personal gain.
- b. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

**ARTICLE VI**

Upon the dissolution or winding up of the Corporation, its assets remaining after payment of or provision for payment of all debts and liabilities of this Corporation shall be distributed to a nonprofit Corporation or Foundation that is organized to operate exclusively for Public Benefit, Charitable and Religious purposes within the means of the Department of the Treasury, Internal Revenue Service Code § 501(c)(3) et seq.
