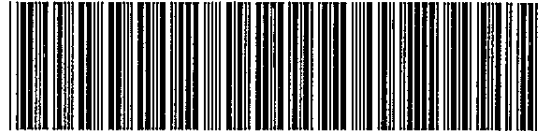



Powers and Purpose

ARTICLE 103

(g) Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purpose the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Loans

ARTICLE

8.06 This Corporation will make NO loans to any of its Members', Directors', or Officers'. No part of any net earnings, at any time shall inure to the benefit of any private individual shareholder or any other private person.

Corporate Dissolution

ARTICLE

8.09 Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.
