The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the FLORIDA NOT FOR PROFIT CORPORATION ACT.

**ARTICLE I – CORPORATE NAME**

The name of the corporation is:

**ARTICLE II – DURATION**

This corporation shall exist perpetually unless dissolved according to Florida law and will begin on July 18, 2002.

**ARTICLE III – PURPOSE**

The specific purpose(s) for which the corporation is organized are to Foster Local, National or International Amateur Sports Competition, as defined in section 501( c ) ( 3 ) of the Internal Revenue Code, dedicated to the promotion and development of amateur sports and physical fitness programs in the local community.

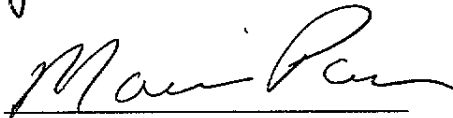
### ARTICLE X – INDEMNIFICATION

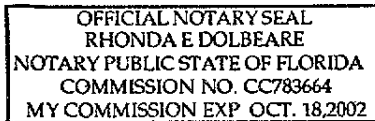

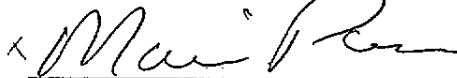
