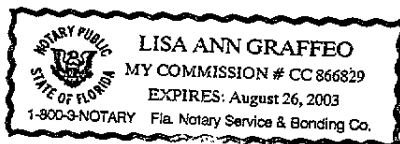
As of 01JAN02, the corporation named PORT RICHEY CHAPTER, INC. was dissolved and has no plans to reinstate its status as a corporation of any type.
