



ARTICLES OF INCORPORATION

FOREST CREEK HOMEOWNERS ASSOCIATION OF SARASOTA, INC.

ARTICLE VI BOARD OF DIRECTORS

A. The affairs of the Association shall be managed by a Board of Directors consisting initially of three Directors. The number of Directors comprising succeeding Boards of Directors shall be decided by a majority of the Board, but in no event shall there by less than three or more than five Directors and shall always be comprised of an odd number of Directors. The Directors need not be members of the Association or residents of the State of Florida, so long as the Developer retains the right to appoint a majority of the Board of Directors. Thereafter, All directors shall satisfy the qualifications stated in Article VI, Section 1. of the Bylaws be members of the Association and residents of the State of Florida.
