## ARTICLES OF INCORPORATION

## **FOR**

## RUTH NELSON KRAFT AWARDS FOUNDATION, INC.

FIRST: The corporate name that satisfies the requirements of Section 617.0401 is: RUTH NELSON KRAFT AWARDS FOUNDATION, INC.

**SECOND:** The purposes for which the corporation is organized are exclusively religious, charitable, literary, and educational, including, but not limited to, the following:

- 1. Engaging in charitable activities and extending financial aid through grants, gifts, contributions, or other aid or assistance to qualified charitable organizations;
- Acquiring or receiving from any individuals, firms, associations, corporations, trusts, foundations, or any governmental subdivision, unit or agency, by deed, gift, purchase, bequest, devise, or otherwise, cash securities, and other property, tangible or intangible, reinvesting and disbursing the principal and income thereof solely for the purposes hereof; and
- Doing whatever is deemed necessary, useful, advisable, or conducive, directly or indirectly, to carry out any of the purposes of the corporation, including the exercise of all other authority enjoyed by corporations generally by virtue of the provisions of the Florida Nonprofit Corporation Law.

The corporation shall carry on only such activities as are consonant with the purposes set forth in this Article Second. No part of the net earnings of the corporation shall inure to the benefit of any incorporator, member, or trustee of the corporation, or of any other private individual, except that the corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article Second. No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation; and no activity of the corporation shall consist of participating in, or intervening in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office.

It is intended that the corporation shall have the status of an organization (a) which is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, (b) to which contributions are deductible for federal income tax purposes under Section 170(c)(2) of the Internal Revenue Code, (c) to which bequests are deductible for federal estate tax purposes under Section 2055(a)(2) of the Internal Revenue Code, and (d) to which gifts are deductible for federal gift tax purposes under Section 2522(a)(2) of the Internal Revenue Code. These articles shall be construed, and all authority and activities of the corporation shall be limited, accordingly. All references in these articles to Sections of the Internal Revenue Code shall be considered references to the Internal Revenue Code of 1986, as from time to time amended, to the corresponding provisions of any similar law subsequently enacted, and to all regulations issued under such sections and provisions.

This corporation is organized under a non-stock basis.

SIXTH:

The method of election of trustees is stated in the Code of Regulations.
