ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

RUTH NELSON KRAFT AWARDS FOUNDATION, INC. (present name)

DOCUMENT NUMBER OF CORPORATION: NO 2000005571

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendments adopted: Article Second of the original Articles of Incorporation are amended to add the following:

- (A) The corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- (B) The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- (C) The corporation shall not retain any excess business holding as defined in Section 4943(c) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- (D) The corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.
- (E) The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent Federal tax laws.

SECOND: Amendments adopted: Article Third of the original Articles of Incorporation are amended to delete the existing provisions and substitute therefor the following:

THIRD: The date of adoption of the Amendments was March 25, 2003.
