distributable to its directors, officers or other private person, except that the Corporation shall be

authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in furtherance its purposes. No substantial part of the activities of the

Corporation shall be the carrying of the propaganda, or otherwise attempting to influence

legislation, and the Corporation shall not participate in, or intervene in (including the publishing

or distribution of statements) any political campaign on behalf of, or in opposition to, any
