Articles of incorporation were adopted at a duly called organizational meeting of Gospel Assembly of Bradenton Florida on July 18, 2002 at 8:35 pm (Eastern Standard time).

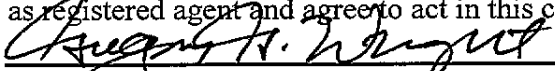

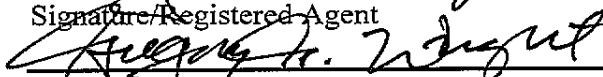
