ARTICLES OF INCORPORATION

In compliance with the requirements of Chapter 617, Florida Statutes, the undersigned, being a resident of the State of Florida and of full age, hereby forms a corporation not for profit in accordance with the laws of the State of Florida, and certifies as follows:

ARTICLE I

NAME

The name of this corporation is VICTORY WAY CHURCH, INC., hereafter called the "Corporation".

ARTICLE II

OFFICE

The initial principal office and mailing address of the Corporation shall be 7411 East Comanche Avenue, Tampa, Florida 33610-4201, which office may be changed from time to time by action of the Board of Directors.

ARTICLE III

REGISTERED AGENT AND OFFICE

The street address of the Corporation's initial registered office is 7411 East Comanche Avenue, Tampa, Florida 33610-4201 and the name of its initial registered agent is Bruce G Holt.

ARTICLE IV

PURPOSE OF THE CORPORATION

The purposes for which the Corporation is organized shall be to buy, purchase, own, acquire by gift, devise, purchase or otherwise, real and personal property and to build, erect, construct, provide for, maintain, and equip suitable buildings, churches, houses, etc., for the benefit, use, and occupation of VICTORY WAY CHURCH, INC., its members and congregation, in maintaining and fostering public worship and the preaching and

teaching of the Word of God and Gospel of Jesus Christ, and for all other meetings and purposes of the said VICTORY WAY CHURCH, INC., its members and congregation.

To Build, construct, erect, maintain and equip schools, mission stations and mission churches, pastors' homes and such other houses or equipment as the said church may desire for carrying on its work.

To receive, administer, disburse and/or invest gifts, devises and bequests by or from any persons or corporations.

To issue bonds, notes, debentures and evidences of indebtedness and to secure the same by mortgage, deed of trust or otherwise.

To license and ordain Ministers, and for apostleship to missionaries, evangelist and for pastoral duties of the Church.

This corporation is organized primarily for the purpose of holding the title to such property of properties as the VICTORY WAY CHURCH, INC., shall from time to time purchase or acquire, and shall have power to make such contracts and do such things as shall be authorized and directed by its members.

This corporation shall have the power to mortgage, sell, encumber, deed or otherwise disburse any property that may belong to the VICTORY WAY CHURCH, INC.

ARTICLE V

POWERS OF THE CORPORATION

The corporate powers of the Corporation are as provided in Florida Statutes Section 617.0302.

ARTICLE VI

MEMBERSHIP

Membership shall be determined as set forth in the By-Laws and any member of the VICTORY WAY CHURCH, INC., shall be held and considered a member of the corporation.

ARTICLE VII

MANAGEMENT OF AFFAIRS

The affairs of this corporation shall be managed by a Board of Trustees consisting of four members who shall be elected from among its membership at the business meeting of said

church or at a special meeting duly called for that purpose, to serve until they resign, leave or are voted out for misconduct.

Trustees shall elect from its membership a President, Vice-President, Secretary and Treasurer.

All deeds, conveyances, notes or mortgages pertaining to the real estate of the corporation shall be executed under the seal of the corporation and shall be signed by the President of the Board of Trustees and attested to by the Secretary of said Board. No real estate owned by the corporation shall be sold, mortgaged or disposed of by the Trustees without the matter of the proposed sale or mortgage being submitted to and approved by 2/3rds majority of active members present at the monthly business meeting or a special meeting duly called for that purpose.

ARTICLE VIII

ARTICLE IX

AMENDMENT OR ALTERATION OF BY LAWS

The by-laws of the corporation shall be made, adopted or considered by the members of the VICTORY WAY CHURCH, INC., at the annual meeting of said church or at a special meeting duly called for that purpose, but any amendment or alteration of said by-laws shall be made only by a 2/3 vote of the active church members present at the meeting.

ARTICLE X

AMENDMENT OF ARTICLES OF INCORPORATION

The Articles of Incorporation of this corporation shall be amended only by a 2/3 vote of the active church members present at any regular business meeting or at a special meeting called for that purpose of amending said Articles of Incorporation.

ARTICLE XI

DISSOLUTION OF CORPORATION

In the event of dissolution of this corporation, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or to the Federal, State or local government for exclusive public purpose.

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue code of 1954 or the corresponding provision of the any future United States Internal Revenue Law, or (b) a corporation to which contributions are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Code.

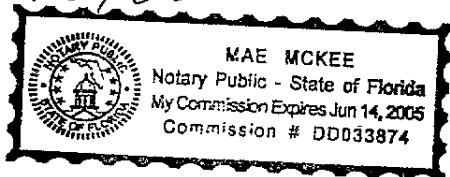
