The undersigned subscribers to these Amended Articles of Incorporation, natural persons competent to contract, hereby files these Amended Articles of Incorporation, amending the original charter and changing the name of said corporation, a non-profit corporation in accordance with and under the laws of the State of Florida.

**ARTICLE I - CORPORATE NAME**

The name of the corporation is "**CENTRAL FLORIDA PUBLIC SAFETY EMPLOYEES ASSISTANCE CORPORATION, INC.**"

**ARTICLE II - DURATION**

This corporation shall exist perpetually unless dissolved according to Florida law.

**ARTICLE III - PURPOSE**

The corporation is organized as a non-profit organization for the purpose of providing collective bargaining, police officer and correctional officer bill of rights assistance and other assistance related to the employment of correctional officers, law enforcement officers, firefighters and other public safety employees.

**ARTICLE IV - NON-STOCK CORPORATION**

The corporation shall be non-stock, and no dividends or pecuniary profits shall inure to the benefit of anyone. Members of the Corporation shall be admitted pursuant to the By-laws.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE VI - PRINCIPAL OFFICE OF CORPORATION**

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

This corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than three (3). #### **ARTICLE IX - BY-LAWS**

The power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors.

#### **ARTICLE X - ELECTION OF BOARD OF DIRECTORS**

Changes in the number of directors or in the initial Board of Directors shall be by vote of the shareholders and shall require a majority vote to effect a change. Elections shall be according to the By-Laws of the Corporation.

#### **ARTICLE XI - DECISIONS OF BOARD OF DIRECTORS**

Decisions of the Board of Directors effecting the nature of the business of the Corporation or dissolution of the Corporation shall require a majority vote to be effective.

#### **ARTICLE XII - ACTIONS BY DIRECTORS WITHOUT A MEETING**

Members of the Board of Directors of this Corporation may take action by written consent, as provided by law.

#### **ARTICLE XIII - MEETINGS BY CONFERENCE TELEPHONE**

Members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone, as provided by law.

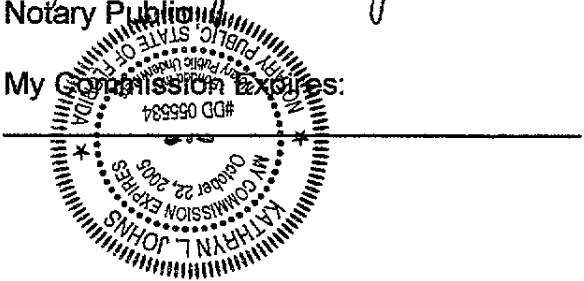
