ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

Emerald Coast All-Stars Parents Association, Inc.

ARTICLE II PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE (S)

The specific purpose(s) for which the corporation is organized is (are):

- A. The purposes for which Emerald Coast All-Stars Parents Association, Inc. is organized are exclusively charitable, and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or corresponding sections of any prior of future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.
- D. There are no members entitled to vote on amendments to the Articles of Incorporation. Any amendments will be adopted by the board of directors.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

By group voting of the members of the Emerald Coast All-Stars Parents Association, Inc.
