ARTICLES OF INCORPORATION OF INNER PEACE : ENTER PEACE MINISTRIES, INC.

ARTICLE I

Name

The name of this ministry shall be known as Inner Peace : Enter Peace Ministries, Inc., a non-profit corporation.

ARTICLE II

Address

The initial post office address of the principal office or place of business of said ministries in the State of Florida shall be 4990 County Road 12, Tallahassee, Florida 32312. The Board of Directors of said ministries may at their discretion move the principal place of business, office or headquarters to another address within the City of Tallahassee.

ARTICLE III

Purpose

The purpose for which Inner Peace : Enter Peace Ministries, Inc. are organized, is to heal the hurting soul. The ministries are designed to provide a place for people with hurting souls to be healed by receiving wisdom and knowledge through educational materials based on biblical principles. Whereas, providing the participants an opportunity to restore peace within their lives: spiritually, mentally, emotionally, financially, socially, and morally. Inner Peace : Enter Peace Ministries, Inc. are exclusively biblical, charitable, and educational within the guidelines of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any further United States Internal Revenue Law. In addition, this corporation exists to seek and accept grants, donations, funds, or gifts, from any source to assist in providing funds for the programs operated and approved by Inner Peace : Enter Peace Ministries, Inc.

This ministry shall not be operated for profit but shall be operated exclusively for the purposes stated above. No part of the net earnings of the ministries shall inure to the benefit of any member, director or officer of the ministries or any private individual, except that reasonable compensation may be paid for services rendered to or for the ministries in the performance of its corporate purposes. The ministries' assets shall never be directed from the purposes stated above. No member, director or officer of the ministries nor any private individual shall be entitled to share in the distribution of any of the ministries' assets on its dissolution. No substantial part of the activities of the ministries shall be the carrying on to propaganda, or otherwise attempting to influence legislation and the ministries shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV

Management of Corporate Affairs

The powers of this ministry shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors consisting of not less than thirteen board members. The number of directors herein provided may be changed by the By-Laws duly adopted by a two-thirds (2/3) vote of the members entitled to vote. Directors shall be elected annually by a majority vote of the membership. To preserve continuity of the Board, the terms of office shall be staggered as set forth in the By-Laws. The Board members shall choose annually from among themselves a person to serve as Chairperson of the Board.

ARTICLE V
