

WE, the undersigned, hereby associate ourselves together for the purpose of forming STATE TALLAHASSEE FLORIDA Corporation under the laws of the State of Florida, pursuant to Florida Statutes 617 Et Seq., and hereby certify as follows:

ARTICLE I

The name of the Corporation shall be:

CRISTAL VILLAS CONDOMINIUM ASSOCIATION, INC.

The corporation's address and mailing address is:

ARTICLE II

The general purpose of this Non-Profit Corporation shall be as follows: To be the "Association" (as defined in the Condominium Act of the State of Florida, F.S. 718 Et Seq.) for the operation of CRISTAL VILLAS CONDOMINIUM, a Condominium, to be created pursuant to the provisions of the Condominium Act, and as such Association, to operate and administer said Condominium and carry out the functions and duties of said Condominium Association, as set forth in the Declaration of Condominium establishing said Condominium and Exhibits annexed thereto.

Section 1. The affairs of the Corporation shall be managed and governed by a Board of Directors composed of not less than three nor more than the number specified in the By-Laws. The Directors, subsequent to the first Board of Directors, shall be elected at the annual meeting of the membership, for a term of one year, or until their successors shall be elected and shall qualify. ARTICLE VIII

The following persons shall constitute the first Board of Directors and shall serve until the first election of the Board of Directors at the first regular meeting of the membership: Paul Hernandez, Alfredo Rippes and Gary V. Smith.

ARTICLE IX

The By-Laws of the Corporation shall initially be made and adopted by it's first Board of Directors.

Prior to the time the property described in Article II hereinabove has been submitted to Condominium ownership by the filling of the Declaration of Condominium, the By-Laws may be amended, altered, supplemented or modified by the membership at the Annual Meeting, or at a duly convened special meeting of the membership attended by a majority of the membership, by vote, as follows:

ARTICLE XII

There shall be no dividends paid to any of the members nor shall any part of the income of the corporation be distributed to it's Board of Directors or Officers.
