ARTICLES OF INCORPORATION OF

PROJECT NEHEMIAH, INC.

The undersigned incorporator, for the purpose of forming a corporation and the Florida Not for Profit Corporation Act, hereby adopts the following Afficles of Incorporation:

- 1. The name of the Corporation is **PROJECT NEHEMIAH**, **INC.**
- 2. The principal place of business and mailing address of this corporation shall be:

1017 Arezzo Circle Boynton Beach, FL 33436.

- 3. The specific purpose for which the corporation is organized is to reach Ethiopians and Eritreans worldwide with the knowledge of Jesus Christ through various means.
- 4. The manner in which the directors are elected or appointed is that the directors are appointed by the incorporator and thereafter the directors are elected pursuant to the Bylaws of the corporation.
