TWO:

This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to Housing, Education, Transportation, and Childcare, Counseling, Tutoring, One-Stop Referral Center and other programs to aid those in need.

THREE:
