

ARTICLES OF INCORPORATION
OF
FRIENDS OF TRINIDAD & TOBAGO INC.
(A FLORIDA NON PROFIT CORPORATION)

I, the undersigned, being a natural person, competent to contract, and acting as an incorporator, do hereby subscribe to the following Articles of Incorporation for the purpose of creating a Not-for-profit Corporation under Florida Statute 617.

ARTICLE 1 – CORPORATE NAME

The name of the corporation is: **FRIENDS OF TRINIDAD & TOBAGO INC.**

ARTICLE 11 – DURATION

The duration of the Corporation is perpetual.

ARTICLE 111 – LOCATION

ARTICLE 1V – PURPOSE

This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are:

- A. To educate the public concerning the culture and traditions of the people of the Caribbean Islands.
- B. To hold seminars, meetings, and events to promote the interest in and knowledge of the Caribbean peoples through the dissemination of accurate information, and
- C. To cultivate the friendship and common interest of the members, and
- D. To interface with other local, county, National, and international community organizations, and
- E. To exercise all rights and privileges of nonprofit corporation conferred by Florida law within the restrictions of the Internal Revenue Service Code, 501-(C) (3).

The initial Board of Directors shall have three (3) members who shall be elected in the manner set forth in the by-laws of the Corporation and may be amended from time-to-time as therein provided.

ARTICLE V1 – LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes. The corporation is created in contemplation of meeting all requirements of the Internal Revenue Code 501-(C) (3) and is not for the private gain of any person.
