ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:
Express.net Pilots Association, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

ARTICLE IV MANNER OF ELECTION

The manner in which the directors/offices are elected or appointed:

Section 1. All candidates for and holders of elective offices and positions, whether elected or appointed, shall maintain membership in good standing. Failure to do so shall result in ineligibility to hold such office or position and shall constitute an incapacity with regard to such office or position.

Section 2. Elections of officers will be held every two years. Elections shall be held by referendum and all balloting shall be done by use of a secret ballot. Write-in votes shall not be permitted and any such vote for any office shall be void. Each ballot envelope shall have on its face an official number assigned to each member.

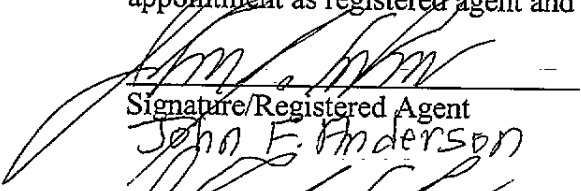
