ARTICLES OF INCORPORATION

FOR

EL TRIUNFO, INC.

A FLORIDA NOT-FOR PROFIT CORPORATION

We, the undersigned, all of whom are of legal age, do hereby associate ourselves for the purpose of becoming a not for profit corporation under Chapter 617 Florida Statutes, and Section 501(c)(3) of the Internal Revenue Code of the 1986, submit the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be:

El Triunfo, Inc.

ARTICLE II

ADDRESS

The address of the corporation's principal office is:

with the privilege of having branch offices at other places within or without the State of Florida.

ARTICLE III

DURATION AND COMMENCEMENT

The corporation will exist perpetually, commencing with the filing of these Article of Incorporation with the Department of State, unless sooner dissolved according to the law.

ARTICLE IV

1 - The purpose for which El Triunfo, Inc. is organized are exclusively for religious, charitable, scientific, fraternize, literary and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

To make distributions to organizations that qualify as exempt Organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 as amended (or the Corresponding provision o any future United States Internal Revenue Law).

2 - To provide and maintaining communication between the families original of the municipality of Sagua la Grande, Cuba in order to preserve their common roots and to keep the memory of friends and remember events lived by the people of this municipality.

3 - To provide assistance and support, both economic and otherwise to individuals who are originals from this municipality, and their families.

4 - To erect, construct, purchase, repair, improve, maintain real estate of every kind, to raise funds and purchase supplies.

5 - This corporation is organized and operated exclusively for charity, pleasure, recreation, and other non-profit activities, and no part of any earnings shall inure to the benefit of any member, director or officer.

ARTICLE V

PROHIBITED ACTIVITIES

The corporation shall not engaged in any activities prohibited by Section 617.0835 of the Florida Statutes.

ARTICLE VI

NUMBER OF DIRECTORS

The number of directors of this Corporation shall be not less than four and no more than seven.

ARTICLE VII

DIRECTORS

The directors of the corporation shall be elected in the manner set forth in the Bylaws of the Corporation.

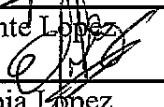
ARTICLE XI
