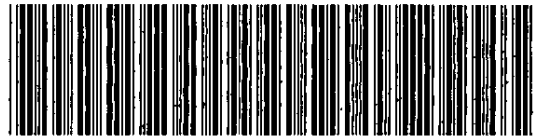

**FIRST ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
FOR
SKYVIEW CHURCH OF CHRIST OF LAKE LAND, FLORIDA, INC.**

1. The following provisions of the Articles of Incorporation of SKYVIEW CHURCH OF CHRIST OF LAKE LAND, FLORIDA, INC., a Florida not-for-profit corporation, filed in Tallahassee on July 11, 2002, with an effective of July 11, 2002, be and they hereby are amended in the following particulars:

1. ARTICLE XI - INITIAL BOARD OF TRUSTEES is hereby deleted in its entirety and replaced with the following new provision entitled:

ARTICLE XI - BOARD OF TRUSTEES.

The management of this Corporation shall be vested in a Board of Trustees. The minimum number of Trustees constituting the initial Board of Trustees shall be three (3). The number of Trustees may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three (3) persons. The Leadership of the Church shall elect the Trustees at an annual meeting. (For purposes of this provision, the "Leadership of the Church" shall consist of the Minister, Elders, Deacons and Brothers Appointed to Lead, each of whom shall have one (1) vote.) The Corporation's Bylaws may also provide for ex officio and honorary Trustees, and their rights and privileges. In the event of a voting deadlock or other impasse reached by the Board of Trustees, the Minister of this Corporation, sitting ex officio as a additional member of the Board of Trustees, shall be entitled to one (1) vote.


