Articles of Incorporation
(pursuant to Chapter 617, F.S.-Not for Profit)

Article I

The name of the corporation shall be:

Bradenton Community Children's Chorus, Inc.

The Bradenton Community Children's Chorus, Inc. shall be herein referred to as BCCCI for purposes of this document.

Article II

The principal place of business and mailing address of this corporation, BCCCI shall be:

Article III

The purpose for which the BCCCI is organized is to develop a community based music expression which will serve to promote peace and develop diversity between people of all distinctions. This will be accomplished by providing a holistic educational format which utilizes the universal language of music, established music education methods, purposeful cross cultural performances experiences or gatherings, and common ground venues and celebrations. The essential skill development on which this premise is based will include basic understandings of the components of the language of music, and the elements of artistic presentation, and concepts of sharing and teamwork for community development.

BCCCI will provide a curriculum which is appropriate for people of all ages but which is specifically directed to meet the needs of children

between the ages of 8 through 12, with additional openings for some younger and some older individuals. Further, BCCCI will provide a community endeavor which will include children of diverse ethnic and socio-economic backgrounds through the greater Manatee County area. The BCCCI will seek and obtain financial assistance for those children who would be interested in participating but whom would not otherwise be able to participate.

Article IV

The Board of Directors shall be an elected body consisting of a President, Vice President, Secretary, Treasurer and Director. These shall be nonpaid positions and run for a term of two years. Majority vote by the Board of Directors shall be required for any and all decisions effecting the operations, and management, of BCCCI.


