## NOT FOR PROFIT ARTICLES OF INCORPORATION

The undersigned incorporator(s) for the purpose of forming a not for profit corporation pursuant to Chapter 617.0202, F.S., adopt(s) the following Articles of Incorporation.

### ARTICLE ONE: NAME OF ORGANIZATION

The name of the corporation shall be: NURSES AND FRIENDS FOR PROPER NUTRITION AND WELLNESS INC.

### ARTICLES TWO: PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be: 9845 SW 184 St., Miami, FL 33157

### ARTICLE THREE: PURPOSE OF ORGANIZATION

The general purposes for which the corporation is organized are:

1. To promote nutritional awareness especially among minority groups.
2. To enhance wellness through healthy eating habits.
3. To solicit funds and donations in kind to further the education of individuals in healthy eating and wellness.
4. To prepare healthy meals for individuals and families in need.
