**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a nonprofit corporation, under the guidelines for the State of Florida, hereby adopt the following Articles of Incorporation.

ARTICLE II NATURE OF BUSINESS

The corporation is a nonprofit organization, under the umbrella of the Florida East Coast Baptist Association, a member of the National Baptist Convention, USA, Inc. It is not organized for the private gain of any person. It may conduct any activity permitted under state law and the Internal Revenue Code Section 501 (c) (3). In furtherance, its general purpose is to teach each member the disciplines of the Baptist Church.

The Definition of a Baptist Church: We are a group of born again persons, immersed in water on the profession of our faith in Jesus Christ. We recognize Christ as our supreme Lord and Lawgiver. We take His Word as our sufficient and only rule of faith and practice in all matters of conscience and religion. We believe that we are saved by our faith/belief in Christ. We are baptized in the name of Jesus Christ. We are governed by His law and we observe His commandments.

ARTICLE III MISSION STATEMENT
